Dear Sunshine Residents,

I would like to get your attention first on an important subject. Contact Information! Over the we have had many years occasions where the Sunshine Community Directory has come in quite handy for us during an emergency call. We've been able to call someone while there was smoke in their home, others because of a family member needing help, and even when suspicious activity was, well, suspected. If I try harder I will probably come up with better examples to convey just how important and helpful the directory can be for us as your fire department. We have recently had a call where we discovered that the residence occupants were not listed in the directory and because of an emergency at the home were not able to reach them. Luckily it turned out to be a false alarm in

this case, but we may have to break into a home instead of asking you pertinent questions over the phone that can alleviate the problem, without damage. We see the benefits of neighbors being able to reach others in the community for the neighbor-to-neighbor typical communications. We understand that some people may still prefer to keep their numbers unlisted from the Sunshine Community Directory. For those who do not want to be listed in the Sunshine Community Directory, while I highly encourage it, we can

Codes are handled confidentially and it is a code requirement through the International Fire Code, which both Sunshine FPD and Boulder County as the enforcement agency have adopted. We cannot be responsible if we have to break a gate that we have not received the combination for and hope for your cooperation.

# Don Dick's Legacy:

We have had a very generous donation from our former friend, firefighter, board member, and legacy member Don Dick who sadly passed away in 2023. If you were at the recent fall festival you may have heard Jen Lansky giving a heartfelt summary of who Don was, and what all he did for the community from the very early days of the department until recent years. In his application to volunteer that I recently discovered in our archive, he was asked "Why do you wish to become a volunteer?" and answered succinctly "Help SFPD". He did this throughout his long time in the district and will continue to do so with his generous donation. Thank you, Don, from myself and your fellow firefighters. A committee consisting of Josh Shoenfeld, Jen Lansky, and Chien Lin who were all friends and neighbors of Don are working on how to memorialize his contributions. Thank you all.

**Firefighter Update:** The year 2024 has been quite eventful so far for the members of our department. We have had units dispatched to Oregon, California, Idaho, and Wyoming wildfires. The fire service works as well as it does, and not disregard the constant room for improvement, because agencies are supposed to look beyond their own borders. Partly because a single agency cannot possibly be able to handle large incidents on its own. The budget and the available manpower alone wouldn't be able to handle that, and we can see this with every wildfire start in the County, State, and nationally. Helping each other beyond borders is what the spirit of service to others is about.

We have had a record attendance since 2023 when it comes to training and certifications, particularly in wildland fire. This helps us become better and more prepared. Going to wildland fires out of state then allows us to provide training to our firefighters that they don't get at the frequency in our district or county. Imagine having to know a skill that can impact your community, and your own life, and only have a chance to experience it every so often to become good at it. It's not possible. So, the additional classes that our firefighters are taking in combination with the dispatch to State and national fires are crucial. In addition to wildland fire certifications, we have a strong record by our firefighters for structure and medical training and have the highest number of trained medical and structure firefighters in our department's history. We can't stop here and always have to look at what we can streamline, improve, and tweak in our approach and with our limited available funding, but I thought this would be a nice bit of information for you.

<u>A few announcements:</u> Firefighter Malachi Brooks has completed his two years as a Junior Firefighter and is currently attending the Boulder County Fire Academy for his structure fire and Hazmat certifications. Malachi, we all can't wait to see where you will be going with "this". Chris Reid has joined the department and is currently going through his probationary period and is a great addition to the team.

to our residents. This time around we had to reach out to our neighboring communities in Gold Hill and Fourmile to fill up this class because not enough Sunshine residents showed interest in taking the class. I don't know why that is and what else we can do to encourage you to take this class. We can't give you distinct examples of when basic knowledge or lack thereof had a positive or negative impact on the family member's outcome for obvious privacy reasons. Please consider taking this class to learn the skills needed to help the people in your life have a better outcome. In my ideal world, every family member in the foothills of Boulder would take this class. The quality of care in the first few minutes is essential. Thank you, Sherri and David, for getting the certifications and teaching this class on your own time!

**It's About Winter time**: Please ensure that your chimney is cleaned, your furnace is fully operational, portable generators are not placed near your windows during power outages, your tires are swapped to your winter tires, and that you have supplies and emergency clothing in every vehicle you may be traveling in this winter. If you need a list, feel free to contact me. Very importantly, and I understand the difficulty of obtaining one, line up a snow removal service that doesn't just plow your driveway when you are home. Canceling the service while you travel may seem like a good idea, but plenty of times a home is unoccupied when issues arise

and we will need access to your home.

Can You Help Volunteer? Last but very much not least, we need your help. As a busy yet small district we are always looking for help, and not necessarily for the position of firefighter. Although we will be going through our annual hiring round for that position in early 2025. We need auxiliary help to not burn out our firefighters. They do a lot, and for them to justify to their family to do the job in the first place, for free, they cannot always take on the additional projects. We are adding a UTV to our fleet that was recently approved, building a shower in station 1 that is primarily to serve firefighters for decontamination, and building a storage shed among other smaller projects. We are looking for help on that end, and if you are good at project management and delegation, that is a skill we can very much use. We are also looking for an Equipment Manager. This position is a trained position and in charge of delegating and managing truck repair vendors, organizing who takes a truck to a shop and back, or communicating needs with our SFPD truck group to organize a task needing to get done on a truck. This would be ideal for a mechanically inclined person. If you can help out, please contact me at chief@sunshine-fpd.org. Thank you, and have a warm, safe, and fun winter.

# **CWPP** Committee Update By Abby Silver & Alan Kirton

As most of us are likely aware, wildfire can occur in required mitigation actions that are identified during our district (and beyond) at any time of year. There are ways for each of us to reduce our individual and community risk. We hope each resident will do what they can to harden your home and maintain defensible space around your home and other structures. Meanwhile, our CWPP Mitigation Committee is working on landscape-scale (multi-property) fuels reduction projects that will help protect our community as a whole as well as homes in our neighboring districts.

#### HOME HARDENING

Our homes are potentially additional fuel to feed a fire, and ignition could negatively impact your neighbors in addition to the tragic loss to your family. SFPD continues to partner with Boulder County's Wildfire Partners program to help provide information and funding to help with individual efforts. This partnership includes:

#### **Community Chipping**

SFPD is partnering with Wildfire Partners (WP) to provide free chipping. Our spring event included over 30 participants! Fall chipping will begin on October 14 but the deadline for registration was October 8 per the rules set by WP. If this is the first you're hearing about this, and you aren't receiving emails from sfpd-announcements, reach out to Jean Gatza to be added to the list.

#### **Free Individual Home Assessments**

Wildfire Partners offers free assessments to all residents of west Boulder County. If you haven't had one yet, or it's been a few years, we highly encourage you to apply to the program. The program is confidential and voluntary. Those who complete all the

your assessment will receive a certificate that can help with retaining homeowners' insurance and a yard sign that lets firefighters know you've made conditions at your house safer for them to defend it.

### **Rebates for Home Hardening Actions**

Boulder County's Wildfire Partners is offering up to \$500 in rebates for taking any of the following home hardening actions:

- Junk Your Junipers •
- Hardscape the First Five Feet around your home
- Retrofit Combustible Fencing where it attaches to your home
- Screening Vents that could allow embers to penetrate into your home

# SFPD Mitigation Funds Are Available for Home Hardening

The CWPP Committee, with SFPD Board approval, has allocated funding to support improvements to the wildfire resiliency of homes in our district. This is designed as a partnership with Boulder County's Wildfire Partners program. Homeowners who join Wildfire Partners for the first time are eligible. # **CWPP** Committee Update - Cont By Abby Silver & Alan Kirton

Protection Plan (CWPP) document under the name of mitigation work done by Boulder County at Bald the Boulder West Wildfire Authority (BWWA). The four districts continue to work together to plan and implement mitigation projects and to keep our joint CWPP document up to date. The BWWA CWPP document, which was completed in 2023, is posted on the Sunshine FPD website. In our district, we are working on two landscape-scale projects:

#### Dry Gulch South Fuels Reduction **Project-**Underway

The Dry Gulch South Fuels Reduction Project is a 70-acre mitigation project between 3100 and 3600 Sunshine Canyon Drive. The project was divided into three sub-project areas, South, North and East. The cutting and fuel extraction have been completed in the South Project Area (26.8 acres) and the work has been certified by Colorado State Forest Servic (CSFS). Cutting and extraction have begun in the North Project Area and should be completed by late winter or early spring. The East Project Area will follow directly after that.

The mitigation work for Dry Gulch South is being funded by a CSFS Incentives for Local Government Grant, a BOCO Strategic Fuels Mitigation Grant and SFPD's CWPP mill levy

# Dry Gulch North Fuels Reduction Project -Upcoming

We are in the planning and grant writing stage for a 57-acre mitigation project along Sunshine Canyon Drive between 3700 and 4200. This project will tie directly into the Dry Gulch South project and will augment other mitigation projects we have done along the shared driveway at 3701 Sunshine Canyon and

Mountain. We have successfully passed the first phase of a federal grant for this project and will be following up with both state and county grant applications. More information about this and other CWPP projects can be found on the Sunshine FPD website. 2024 CWPP **Project** List

# SIDEBAR:

This type of project is called a shaded fuel break, where the forest is being nudged back toward a tree density closer to what naturally occurred before a century of fire suppression. The risk of catastrophic wildfire is reduced by:

- Reducing the amount of fuel that could ignite thereby reducing fire intensity and creating safer conditions for emergency responders.
- Enhancing forest health mitigating the overcrowding which increases existing vulnerability to disease which makes trees more combustible.
- Protecting homes homes and their contents are a source of increased heat and toxicity during a wildfire event. Home loss is expensive and traumatic for the homeowners and community.
- Providing safer egress conditions along Sunshine Canyon Drive - this impacts evacuation of residents to the west as well as the ability of responders to access our district.

# Sunshine FPD Board News Jean Gatza, Dan Fischer, John Bauer, Pat Noyes, Dick Smith

Your Sunshine Fire Protection District volunteer board of directors has had a busy last few months since the last newsletter. We continue to carefully manage the funds that come from your tax payments and from the many grants we have received this year. These resources in 2024 include \$208,000 from tax revenues, \$198,000 from grants and \$35,000 from donations, as well as interest earnings and contracted fire services funds.

Here's are a few current areas of focus in recent months:

<u>Command Vehicle Grant</u>. Due to a generous grant award from Boulder County, your fire district has been able to purchase a new pickup truck and accessories that will serve as a command vehicle in our district and in support of neighboring districts. We now have a dedicated vehicle for the Chief that will help coordinate department response on calls. The Boulder County Emergency Services grant covered \$80,000 of the cost for the vehicle and most of the accessory equipment.

Don Dick Bequeathment. Most residents in our community who have lived here for a few years remember Don Dick, who served as a firefighter, board member and general volunteer to our community for decades before he passed away early last year. We cannot say enough good things about how important Don was to Sunshine. And then to our surprise, we learned that Don donated more than \$300,000 to the SFPD through his estate! To keep that in perspective, our annual tax revenues for the district are only about <sup>2</sup>/<sub>3</sub> of that amount. It is very important to your board that Don's donation supports the district in a meaningful and enduring way, and we have been gathering ideas for how to do that. Ideas we are considering include funding a critical cistern for the district, funding our reserve for

capital equipment, creating an endowment to support firefighter training and funding a pension plan for firefighters (as many other volunteer districts have). As always, our community is encouraged to weigh in on this and other plans.

District Cistern Plan: Perhaps the most critical weakness we have in defending the homes and properties in our district from wildfires and structural fires is our lack of a sufficient water supply within 1,000 feet of every structure. The strategy to resolve this is to install a series of buried cisterns to meet that goal throughout the district. It is an expensive and challenging mission being led by Fire Marshall Michael Johnson. In the plan, we must consider property owner permissions and easements. engineered plans, county review and permits and a funding gap that may look to property owners to cover costs. We will soon be announcing one or more community meetings to share the initial plan and to gather your input. We encourage everyone to attend.

A special thank you to all our volunteers who make our district possible! The fire team and its leadership, our board of directors, and the volunteers who make our events happen! And thank you to all our community members who support us through their taxes and donations!

**Board Meetings:** The 2nd Tuesday of the month at Fire Station #1 from 6:30 - 8:30 PM. These meetings are always open to the public, and our agenda leaves time for public comment and input.

# **Sunshine Historical Society Update** Pat Noyes

The Sunshine Historical Society manages the Sunshine as the Fall Crafts Fair, historic presentations, Schoolhouse and the Sunshine Cemetery. We are a volunteer organization funded through purely community donations. The vision of the Sunshine Historical Society is to preserve the history and legacy of the Town of Sunshine by preserving and using the Sunshine Schoolhouse and Sunshine Cemetery to enhance the Sunshine community and celebrate its rich mining history. The schoolhouse was built in 1900, replacing the first school that burned in 1876. The cemetery was established on the southern edge of the original Sunshine townsite, with the earliest marked grave dated 1875. These historic properties are a treasure to the Sunshine community and the Sunshine Historical Society is working to identify, prioritize, and fund projects to preserve them as community assets.

Over the next year, the Sunshine Historical Society Board plans to conduct a structural assessment on the schoolhouse to address critical structural issues and improve the usefulness of the building for community functions. Informational signs are planned for both the schoolhouse and the cemetery to give some historic context for visitors. The Board is also looking at repairing the cemetery gate and stone pillars, and developing an aerial map of known plots with digitized historic records. Plans for a new memorial garden are being developed to increase the capacity and plot options for those who want to stay in Sunshine forever. The Board is also interested in expanding the use of the schoolhouse for community and private functions. These include community programs and events, such

fund-raising events and holiday parties.
